The Powerlines Group is strategically expanding its ENERGY business in Germany through its 100% subsidiary Powerlines Energy Germany and is thus investing in the future.

Norbert Hänsel, Managing Director of Powerlines Energy Germany: 'Powerlines Energy Germany was founded in 2016 with a fairly small team at Ehingen to drive the internationalisation of the ENERGY business sector. We have now most definitely grown beyond the initial start-up phase, and we have developed into an established provider on the German energy market. Now we will continue this successful growth."

In November 2018, the dismantling work started in the Wesel-Meppen project. Powerlines Energy Germany was commissioned by Amprion GmbH to refit the existing 220-kV transmission line, upgrading it to a 380-kV-line. Once completed, this new 380-kV-line will become one of the major main axes for the transport of electricity from North to South Germany. Completion of the project with a volume of more than EUR 15 million for Powerlines Energy Germany is planned for 2020.

Since January 2019, Carsten Gärtner has strengthened the Powerlines Energy Germany team as very experienced Managing Director. Carsten Gärtner: 'I am very much looking forward to the new challenges within the Powerlines Group, and to working together with the entire team.'

Furthermore, Powerlines Energy Germany is to increase its regional presence with the establishment of two new offices in 2019, one serving the North-West and the other the North-East region. The team will be expanded in all areas and further development of the engineering department is underway. As well as providing engineering expertise in terms of



statics, Powerlines Energy Germany will also be able to provide in-house services in design, routing and construction.
