VLB Leitungsbau awarded Weinviertel line replacement contract by Austrian Power

VLB Leitungsbau to install 380-kV transmission line between Prottes and Neusiedl an der

Zaya in Lower Austria

Contract volume: Approx. €25 million

Via its Austrian ENERGY subsidiary VLB Leitungsbau, the Powerlines Group has been awarded

a contract to build the new replacement power transmission line system by Austrian Power

Grid AG (APG) along a section of the Weinviertel route. Among Europe's main players

involved in the electrification of railway infrastructure and as a leading provider for the

installation of energy transmission infrastructure in Austria and Germany, the Powerlines

Group is part of ENGIE Solutions, subsidiary of ENGIE, one of the world's leading groups

involved in the transition over to a zero-carbon world. VLB Leitungsbau has been contracted

with the construction of a new 2-system 380-kV line on the route between Prottes and

Neusiedl an der Zaya. As well as installing the replacement infrastructure, the contract also

involves dismantling the current 220-kV line. Dismantlement is to be conducted subsequent

to the commissioning of the newly installed 380-kV Weinviertel transmission line. Initial

building work commences in autumn 2019.

The existing 220-kV power line in the Weinviertel region of Lower Austria was erected in the

1950s and - after such a long period of operation - is in need of modernisation and

rehabilitation to meet the requirements placed on today's high-performance power supply

infrastructure. The line routing for the new Weinviertel transmission line has been optimised

and shortened. In future, it is to run alongside - and through - the region's wind parks at a

greater distance from local residential housing. The reconstruction of the Weinviertel

transmission line is to make a long-term contribution to securing grid power supply in Lower

Austria and will be of significant benefit to the process of integrating renewable energy

sources into the power mix in the region, subsequently ensuring requirements are met for ecologically sustainable energy provision from wind and solar power. VLB Leitungsbau's highly-experienced installation team will be responsible for erecting 81 power line masts and the requisite mast foundations along a 26 km section of the route. This equates to 3100 metric tons of mast steel and around 6,500m³ of mast foundations, 468 km of 380-kV power cable and 26 km of earthing wire. Additionally, the APG contract includes the dismantlement of approximately 300 metric tons of old transmission lines and around 900 tons of mast steel. "I congratulate VLB Leitungsbau on being awarded the Austrian Power Grid AG contract, and I am delighted that by being given responsibility for implementation, we will be making a vital contribution to ensuring the supply of power in Austria on a long-term basis. The contract volume of around €25 million makes this one of the largest in the history of our ENERGY subsidiary", stated Gerhard Ehringer, CEO of the Powerlines Group.
